# Connection fee rebates for new Trading Members affiliated with existing Trading Member

Trading Members newly admitted to Eurex Deutschland on or after 1 September 2018 ("new Trading Members"), that are affiliated<sup>1</sup> with a company admitted as a Trading Member to Eurex Deutschland before 1 September 2018 ("existing Trading Member"), may register for a temporary rebate on their connection fees according to Eurex circular 070/19.

To register, a new Trading Member has to submit the Member ID of the affiliated existing Trading Member. The registration form has to be signed by authorized persons (stated on the signature list provided to Eurex Deutschland) of the applying new Trading Member and the affiliated existing Trading Member. The signatories confirm that both companies are affiliated within the meaning of Footnote 1 and acknowledge that connection fee data of both companies will be used to calculate the rebate.

Please note that the rebates on connection fees will be deducted from the invoice for the following calendar month on a monthly basis, e.g. rebates granted for October 2018 will be deducted from the invoice for November 2018. Rebates will be applied on the monthly connection fees incurred by the Applicant between October 2018 and October 2019 (including).

<sup>1</sup> "Affiliate" shall mean with respect to any company, any other entity that, directly or indirectly, through one or more intermediaries, controls or is controlled by such company or is under common control with the company in question. For purposes of this definition, "control" means the possession, directly or indirectly, of 50 percent or more of the equity interests of a company or the power to direct or cause the direction of the management and policies of a company, whether through ownership of voting securities, by contract or otherwise.
