# Eurex Repo Technical Information (update)

Eurex Repo F7 production v3.5 update (with optional API upgrade)

**Summary:**

The **Eurex Repo F7 PRODUCTION environment** will be **updated** to version **F7 release 3.5 on Saturday, April 10th, 2021.**

On Saturday evening, an [Implementation News](#) will announce the completion of the update. After the update, the production system will be technically available in unattended mode (not technical support).

With the start of the business day on **Monday, April 12<sup>th</sup>, 2021 the software version for Repo F7 production will be 003.540.000.**

Release 3.5 includes GUI enhancements as well as an optional F7 API upgrade. API customers (including ISVs) will be provided a new set of updated XSDs for release 3.5 in the Eurex Repo member section, together with an updated F7 API manual describing all changes in detail.

F7 API customers that choose not to introduce the new F7 API features may continue to use the Release 3.4 XSDs with the new software.

Release 3.5 includes enhancements affecting F7 Trading GUI and F7 API users (optional):

- F7 GUI specific enhancements
  - User PINs
  - Trade approvals (four-eyes)
  - New quote history
  - New re-submit feature for pre-trades
  - Pre-trade window improvements
  - Newsboard pop-ups

- Smaller enhancements
- F7 API specific enhancements (optional)
  - Trade approvals (four-eyes)
  - New quote history

F7 GUI users are strongly recommended **to clear the browser cache** after the release introduction, to ensure that the newly introduced GUI functionalities behave correctly.

Details on the various enhancements and features are described in the "[Eurex Repo F7 3.5 Release Notes – Production version](#)" which has been published in the Eurex Repo member section together with a matching set of XSDs for v003.530.000.
