### **1.4.1 Subject Matter of Contract**

### **1.4.2 Obligation for Performance**

- (3) In deviation to Paragraph 1, after the close of trading on the last trading day, the seller of an EXTF Futures Contract on ~~db x-trackers Harvest CSI300 UCITS~~ETF~~Xtrackers Harvest CSI300~~ETF shall pay in cash any difference between the agreed price and the higher final settlement price (Chapter II Part 2 Number 2.5.2 of the Clearing Conditions for Eurex Clearing AG). The purchaser shall pay in cash any difference between the agreed price and the lower final settlement price.
