Fourth Amendment Ordinance to the Admission Regulations for Exchange Traders at Eurex Deutschland

On 26 June 2025, the Exchange Council of Eurex Deutschland approved the Fourth Amendment Ordinance to the Admission Regulations for Exchange Traders at Eurex Deutschland.

It shall take effect 7 July 2025.

Article 1 *Amendment to the Admission Regulations for Exchange Traders at Eurex Deutschland in the version dated 01. November 2007, last amended by the Amendment Ordinance dated 30. March 2023*

§ 8 Procedure of the Exchange Trader Examination

- (1) At the discretion of the Management Board, the Exchange Trader Examination may be held in the physical presence of a supervisory person (in-person examination) or by means of digital communication systems (virtual examination). ~~The Exchange Trader Examination is a presence examination which shall be taken on the premises determined by the Management Board.~~ An oral examination shall not take place. The examination consists of computer-aided examination questions to be answered on the subject areas listed in § 5 Paragraph 2. The Exchange Trader Examination may be carried out in English and German language.

Article 2 Effective Date

The amendments in Article 1 will become effective on 7 July 2025.

The foregoing Fourth Amendment Ordinance to the Admission Regulations for Exchange Traders at Eurex Deutschland is hereby executed. Pursuant to the decision of the Exchange Council of Eurex Deutschland dated 26 June 2025, the Amendment Ordinance shall take effect on 7 July 2025.

The Hessian Ministry of Economics, Energy, Transport, Housing and Rural Areas has given its approval required pursuant to § 16 Paragraph 3 of the Exchange Act in its letter dated 27 June 2025 (File No: 0458-III-037-d-04-05-00003#2025-00001).

The Amendment Ordinance shall be announced by notice in the reception area of the trading floor, Börsenplatz 4, 60313 Frankfurt/Main, Germany and by electronic publication on the internet, available on the website of Eurex (<http://www.eurex.com>).
