#### 1.27.10 Delisting of an Underlying

In such case, the Management Board of Eurex Deutschland shall determine the price of the underlying relevant for cash settlement. The settlement of the contracts shall take place according to the fair value method on the basis of the average settlement prices on the ten days preceding the first public announcement of the delisting, countervalue of the underlying, taking into account the risk-free interest rate in relation to the remaining term and, if applicable, any estimated dividends. If liquidation proceedings, insolvency proceedings or any similar procedure has been opened in respect of the company to which the underlying refers, settlement shall take place, ~~taking into account any dividends already and actually paid, on the basis of the closing price of the underlying on the last trading day before delisting.~~
