#### 3.2.7 ~~Basket Trades of Equity Total Return Futures Contracts~~ Basket Trades and Substitution Trades

Basket Trades and Substitution Trades are admitted for Off-Book Trading according to Number 4.3 (7) of the Trading Conditions of Eurex Deutschland.

##### 3.2.7.1 Basket Trades

The following Contracts may be traded in a Basket Trade are admitted:

When initiating a Basket Trade, the trading system of Eurex Deutschland will generate and attach an identifier to each of the contracts traded in such Basket Trade ("Basket ID").

Single Stock Futures, Single Stock Dividend Futures and Stock Tracking Futures may be traded jointly in one Basket Trade having one Basket ID.

Equity Total Return Futures Contracts must be traded in a separate Basket Trade having an individual Basket ID and may not be combined with Single Stock Futures, Single Stock Dividend Futures and Stock Tracking Futures.

#### **Initiating a Basket Trade**

~~When entering a~~ A Basket Trade is initiated by entering one or more trades in Eligible Contracts as a Basket Trade of Equity Total Return Futures Contracts, the Exchange Participant must enter:

- ~~(i) one or more eligible Buckets as listed in Annex G and~~
- ~~(ii) one or more Equity Total Return Future Contracts assigned to one of the selected Buckets and~~
- ~~(iii) ——— When initiating a Basket Trade of Equity Total Return Futures Contracts, an additional a Profile must be entered pursuant to corresponding to the selected Buckets as listed in Annex G.~~

~~Upon execution of a Basket Trade of Total Return Futures Contracts, the Eurex Trading System will additionally generate a unique identifier to each of the traded Total Return Futures Contracts traded in such Basket ("Basket ID").~~

#### **Subsequent Trades within a Basket Trade**

To the extent additional trades shall be executed within an existing Basket Trade, the following must be entered into the system of Eurex Deutschland:

- (i) a valid Basket ID and
- (ii) Eligible Contracts to be opened or closed.

#### **3.2.7.2 Substitution Trades**

Substitution Trades are only possible for Equity Total Return Futures according to Paragraph 1.26.12.

~~When entering a Substitution Trade, according to paragraph 1.26.12. (5) the Exchange Participant must~~ the following must be entered:

- (i) a valid Basket ID and
- (ii) ~~valid~~the Equity Total Return Futures Contracts to be opened and closed according to paragraph 1.26.12. (2) to (5).
